UPON THE APPLICATION by a Claim Form dated the 27 February 2023

AND UPON READING the evidence

AND IT APPEARING that there is no opposition on behalf of His Majesty to the relief
sought by this Claim as appears from the evidence of service of Abigail Keech and the
exhibit thereto

AND the Claimant undertaking to:

- (A) in the absence of there being a transfer of liability to this Company not seek
damages for alleged personal injury in respect of any period subsequent to its
dissolution



(B) inform the Registrar of Companies of the title and Court reference number of the proposed litigation against the Company referred to in paragraph 5 of the Witness Statement of Asimah Ali dated the 27 February 2023 immediately after issue

(C) inform the Registrar of Companies immediately on the conclusion of the said litigation insofar as it is against the Company or of any appeal therefrom or on the conclusion of the claim against the Company by any other means

AND UPON the solicitors for the Claimant and the Registrar of Companies (the Defendant) both consenting to this Order

IT IS ORDERED THAT:

(1) the name of the above named J.W. Colpitts & Company Limited be restored to the Register of Companies

(2) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 00212468 Limited

(3) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off

(4) the Registrar of Companies do advertise notice of this Order in her official name in the "London Gazette"

(5) the Claimant do pay to the Registrar of Companies her costs of the said
Application in the agreed sum of £300-00
