ORDER

UPON THE PETITION of Philippe Blandinieres of Route des Chasseurs, Thias, 87170 Isle, France; John Michael Bruce Frank of The Old Rectory, Great Langton, Northallerton, North Yorkshire DL7 0TA; Stuart James Redford of Westbridge Manor Road, Baldwins Gate, Newcastle, Staffordshire ST5 5ET; Kenneth Philip Smith of 11 Bracebridge Road, Four Oaks, Sutton Coldfield, West Midlands B74 2SB; Ronald Charles Trenter of The Lodge Cottered Warren, Buntingford, Hertfordshire SG9 9QG; and Anthony William Brierley of Walpole House, West Common, Gerrards Cross, Buckinghamshire SL9 7QS; in their capacity as the directors of Flare Group plc (the "Company").

AND UPON hearing Counsel for the Petitioners.

AND UPON Counsel for the Petitioners undertaking on behalf of the Petitioners to issue the Petition today.

AND UPON Counsel for the Petitioners undertaking on behalf of Mr Anthony William Brierley that he will swear an affidavit substantially in the form of the draft affidavit before the Court.

AND UPON reading the draft affidavit of the said Mr Brierley.

IT IS ORDERED that during the period for which the Order is in force the affairs, business and property of the Company be managed by the administrators hereinafter appointed pursuant to the provisions of Section 8 of the Insolvency Act 1986 for the following purposes:-

- (i) the survival of the Company, and the whole or any part of its undertaking, as a going concern;
- (ii) the approval of a voluntary arrangement under Part I of the Insolvency Act 1986; and
- (iii) a more advantageous realisation of the Company's assets than would be effected on a winding-up.

AND IT IS ORDERED that Alan David Lewis and David Kenneth Duggins both of Arthur Anderson, PO Box 55, 1 Surrey Street, London WC2R 2NT be appointed administrators of the Company.

AND IT IS ORDERED that pursuant to Section 231 of the Insolvency Act 1986, any act required or authorised under any enactment to be done by the administrators may be done by one or both of the administrators.

AND IT IS ORDERED that the requirement to serve the above referred to Petition, the Affidavit of Anthony William Brierley in support thereof and the Exhibits thereto upon the Company and the administrators be dispensed with.

AND IT IS ORDERED that the administrators report to the Court on or before 26 July 2000 on the progress of the administration.

AND IT IS ORDERED that the costs of the said Petition, including the costs of preparation of the report under Rule 2.2 of the Insolvency Rules 1986 (and the legal costs thereof) be paid as an expense of the administration.
