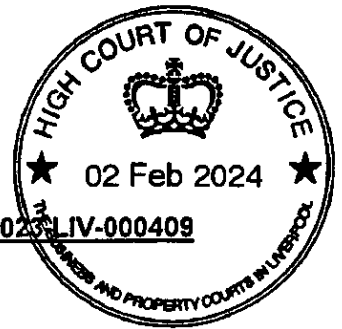

struck off
- (4) the Registrar of Companies do advertise notice of this Order in her official
name in the "London Gazette"

(5) the Claimant do pay to the Registrar of Companies her costs of the said Application in the agreed sum of £300-00
