- (B) inform the Registrar of Companies immediately on the conclusion of the said proposed litigation or any appeal therefrom or the conclusion of the claim by any other means.

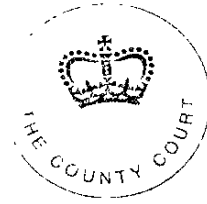

- (5) the hearing fixed for the 6th February 2020 be vacated

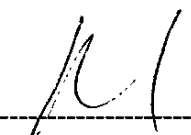

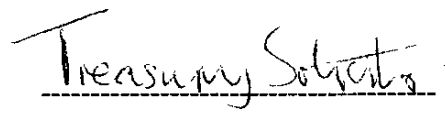
