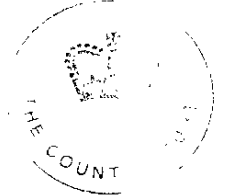

 - (6) the Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette"







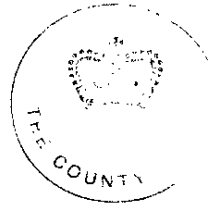
