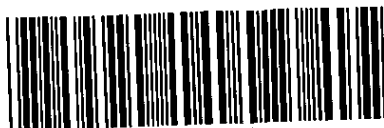

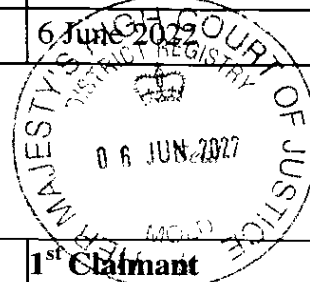

(3) the Claimant do serve a copy of this Order on the Company's former Liquidators within 21 days of the date hereof

(4) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 02786129 Limited
