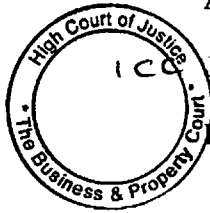

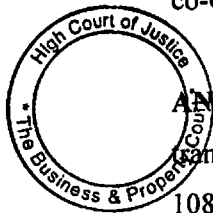

ORDER
