- (5) an Office Copy of this Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the company is thereupon to be deemed to have continued in existence as if its name had not been struck off
- (6) the Registrar of Companies do advertise notice of this Order in his

- (7) the claimant do pay to the Registrar of Companies his costs of the said Application in the agreed sum of £300.00
