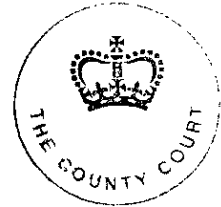

AND UPON READING the evidence



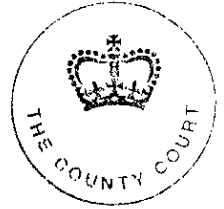

- (B) inform the Registrar of Companies immediately on the conclusion of the said litigation insofar as it is against the Company or of any appeal therefrom or on the conclusion of the claim against the Company by

any other means

(the Defendant) both consenting to this Order

- (1) the name of the above named Castle Interiors Limited be restored to the Register of Companies
- (2) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 03392200 Limited
- (3) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off
- (4) the Registrar of Companies do advertise notice of this Order in her official name in the "London Gazette"
- (5) the hearing fixed for the 4th November 2021 at 2:00 pm be vacated
