IT IS ORDERED THAT:

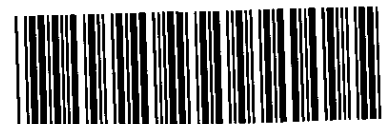
1. The name of 1. RM Support Services Limited (registration number 04542855) be restored to the Register of Companies
