AND UPON the Claimant and the solicitors for the Registrar of Companies (the Defendant) both consenting to this Order

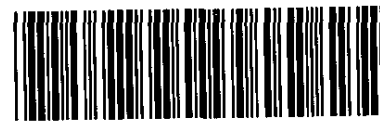




