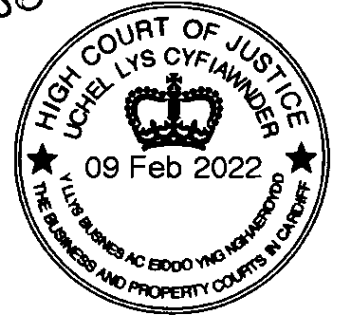

AND UPON READING the evidence

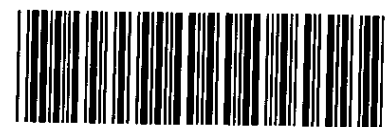
